

Clinical Trials Postings

Raise awareness of your clinical trials with a critical audience

Description

The American College of CHEST Physicians (CHEST) is working to promote awareness of clinical trials that may benefit patients served by our membership of pulmonary, critical care, and sleep medicine physicians and other members of the health care team. CHEST is pleased to offer exhibitors and other companies that are conducting clinical trials the opportunity to share information about their clinical trials at the CHEST 2023 Annual Meeting. Our intent is to provide a service to assist companies that want to meet any or all of the following objectives: raise awareness of their trials and timely clinical developments; recruit principal investigators/sites for their trials; reach clinicians who can help recruit or refer patients into their trials; or address the need for diversity in clinical trials.

CHEST will provide the following:

- 1) A posting of your trial in a kiosk at the CHEST 2023 Annual Meeting in Hawai'i, taking place at the Honolulu Convention Center from October 8–11.
 - Your clinical trial will be featured in a prominent kiosk at CHEST 2023. CHEST will drive attention to the kiosk/trials listing with signage and other promotional tactics throughout the meeting.
- 2) A posting on chestnet.org.
 - CHEST will host a description of the trial on the CHEST website through December 31, 2023.
 - You can include information on your trial and a direct link to your company's dedicated page.
- 3) A listing of your trial in the CHEST Events app
 - CHEST will list your trial on a dedicated page within the official CHEST 2023 Events app.
 - A scheduled push notification from CHEST will direct all attendees to the Clinical Trials page.
- 4) Email post-conference
 - CHEST will send an email to meeting attendees following the conference that features the clinical trials posting.
 - CHEST will stay connected and nurture leads even after the event.

Fees

\$3,000 per trial for companies or organizations that are exhibiting at the CHEST 2023 Annual Meeting

\$4,500 per trial for companies or organizations that are not exhibiting at the CHEST 2023 Annual Meeting

An application must be completed, and fee must be paid for each trial to be posted.

Timing

Applications must be completed and submitted to CHEST by October 5, 2023, in order to be featured during the Annual Meeting taking place October 8–11, 2023. For applications received after October 5, 2023, CHEST may include the trial posting on the chestnet.org website and in the post-conference email.
